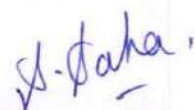

PREFACE

The Sexual Harassment of Women at Workplace (Prevention, Prohibition, and Redressal) Act, 2013 ("POSH Act") is a special legislation that was enacted with the objective of creating safe workplaces for women in our country. As we enter the tenth year of this law, it is time that each of us, who are or will be entering into the work force, are aware of it.

POSH Act was formulated as a result of the Vishaka guidelines given by the Hon'ble Supreme Court of India in the case of Vishaka and Others vs. State of Rajasthan and Others. This judgment came in the backdrop of the Bhanwari Devi gangrape.

It has three major elements- prevention, prohibition, and redressal. As per this act, it is the duty of the employer to provide safe working environment and take steps to prevent and prohibit sexual harassment. The POSH Act also lays down the redressal mechanism and calls for constitution of a dedicated committee to handle complaints.

Are the programs useful and helpful in creating awareness regarding gender discrimination, sexual harassment?

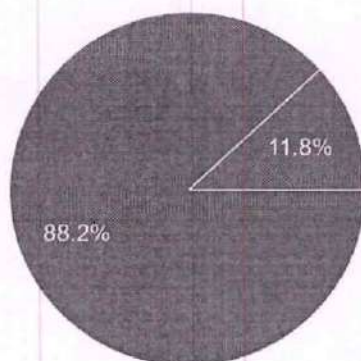

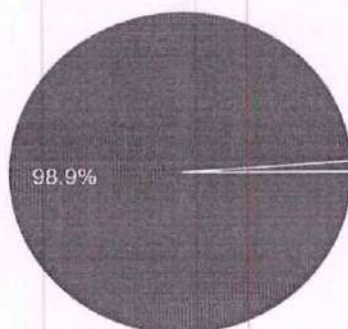

Do you feel safe at campus?

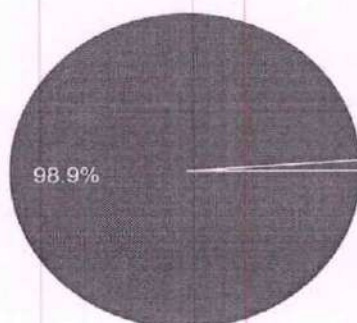

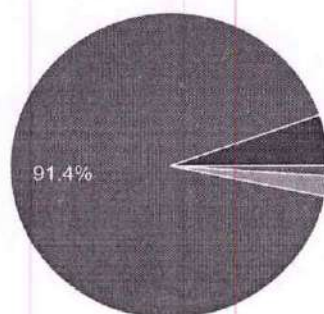

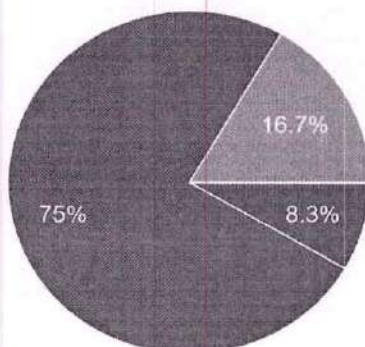

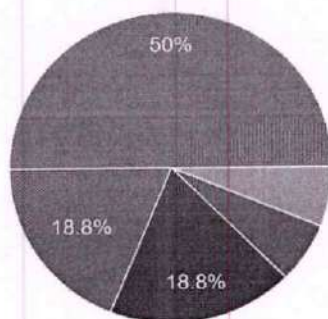

STAFF SURVEY DATA ANALYSIS

The survey reveals that Majority of employees have gender awareness and awareness regarding ICC, role of ICC, work procedure of ICC. Majority of employees are aware of the Vishakha Guidelines/POSH Act. 83.9% are aware and 16.1 are unaware of the Vishakha Guidelines/POSH Act. 98.9% of the respondents are aware of the Internal Complaint Committee and 1.1% are puzzled with Internal Complaint Council. 96.8% of the respondents are aware of the ICC in the college. 88.2% are aware of the different kinds of harassment and 11.8% are unaware the different kinds of harassment. 88.2% respondents are aware of the process of reporting the grievances to the appropriate authorities of the institution. According to 55.6% respondents program organised by ICC are very useful, 39.8% are useful, 1.1% are not so useful and 3.2% bear neutral attitude. 98.9% respondents feel safe at campus. According to 98.9% respondents college has adequate gender-inclusive facilities. According to 88.2% the institution have clear maternity, paternity, childcare and flexible work policies. 79.6% never received or witnessed gendered harassment via institutional digital channel and 13.9% respondents received or witnessed gendered harassment via institutional digital channel. Among them 5.4% once, 1.1% twice, 3.2% multiple times, 4.3% often received or witnessed gendered harassment via institutional digital channel. 6.5% prefers to remain silent regarding the issue. In the opinion of 80.6% respondents the institution have guidelines to prevent and respond to online harassment and 2.2% respondents the institution have no guidelines to prevent and respond to online harassment and 17.2% are not aware regarding this matter. 91.4% respondents have never experienced any instance of sexual misconduct or harassment within the institution. 5.4% prefers to maintain silence, 2.2% experienced multiple times and 1.1% once experienced sexual misconduct or harassment. 97.8% never reported any case of sexual harassment. 16 responses received regarding the cause of non-reporting of incidence of sexual harassment. Among them 50% do not specify any reason 18.8% do not know how to report, 18.8% do not consider it serious/resolved informally, 6.3% mention social stigma/family consequences, 6.3% mention all the causes mentioned here like fear of retaliation/career impact, lack of faith in the process, social stigma/family consequences. Many faculties gave suggestions for the improvement. Some important suggestions are cited below.

More awareness needs to be created among communities

Promote gender sensitivity programs.

To be truly gender-inclusive is to create a safe and gender-neutral space for the LGBTQIA+ community. Like many education institutions have gender-neutral washrooms. This can be a positive step forward to improve the gender climate of the institute. Also, acceptance and awareness come from visibility. So, I would expect awareness programs to call members from the LGBTQIA+ community to raise awareness among students about different sexual identities and address the social stigma concerning the same.

A clear-cut guideline for dealing with cases of digital harassment must be available and publicized

If the ICC prepares a display board clearly outlining the categories of harassment—both online and offline—and presents these categories through different illustrative pictures, it can be placed on the outer wall of the ICC room for awareness.

A Separate girls toilet should be constructed at the 2nd floor of science building where A7 , A8 room situated.

Regular monitoring should be conducted to ensure a safe environment for employees and students.

Though maximum respondents gave positive feedback regarding gender issues,gender violence free environment in the the college but there are some exceptions also. These issues need to be carefully addressed. Different kinds of programs like seminar,invited lecture on gender equality, types of sexual harrassment,Vishakha Guidelines/POSH Act,ICC may be arranged to develop awareness among the employees.

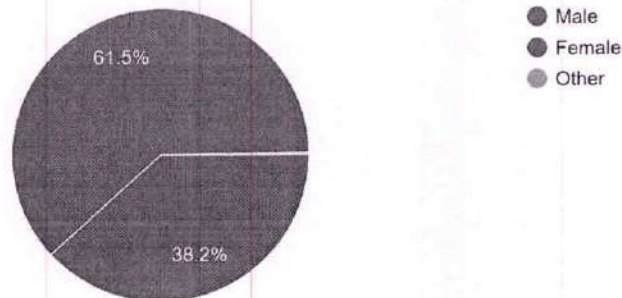

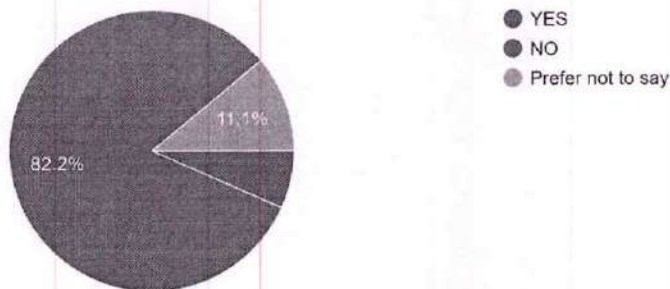

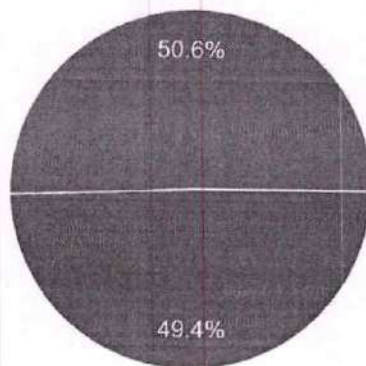

Are you aware of the Vishakha Guidelines/POSH Act?

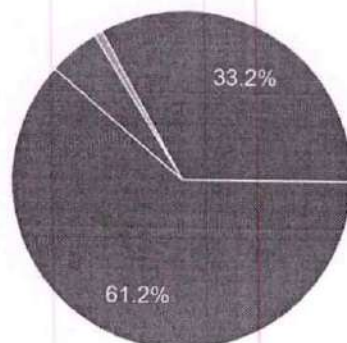

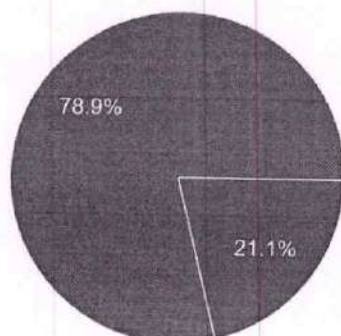

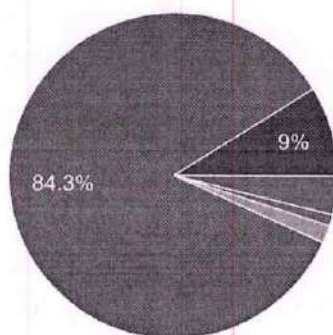

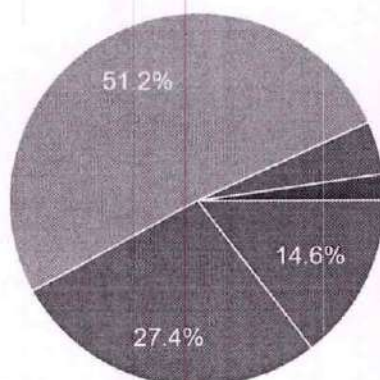

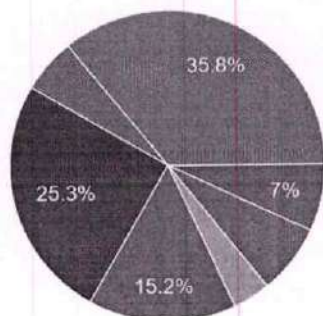

STUDENT SURVEY DATA ANALYSIS

The survey among the students shows that 50.6% are aware of the Vishakha Guidelines/POSH Act and 49.4% are unaware of the Vishakha Guidelines/POSH Act. Among the respondents 82.2% do not identify as LGBTQ+ Community and 6.7%% identify themselves as LGBTQ+ Community and 11.1% choose the option prefer not to say. 61.2% of the respondents know the full form of the Internal Complaint Committee and 33.2% are puzzled with International Cricket Council. 55.1% know the role of ICC. Only 34.3% are aware of the fact that college has a functioning ICC. 69.9% respondents did not attend any program of ICC. For 29.9% respondents programs organised by ICC are very useful. According to 82.4% respondents there is adequate gender-inclusive facilities in the institution. 93.9% respondents said teachers treat students of all gender with respect. 30% respondents uphold the view that gender stereotypes are challenged in classroom discussion and learning material, 38.9% are not aware of the fact. 31.1% respondents answer that gender stereotypes are not challenged in classroom discussion and learning material. 86.8% respondents feel safe in the campus. 21.1% students attended self defense program. Among them 72.4% attended less than 5 programs, 16% attended 5-10 programs and 11.6% attended more than 10 programs. 63% respondents are aware of different kinds of harassment. 72.6% respondents never experienced gender harassment via institutional digital channel. 9.3% once experienced gender harassment via institutional digital channel. 9.3% respondents choose prefer not say option. 4.4% respondents experienced 2-3 times gender harassment via institutional digital channel and 4.4% respondents experienced often gender harassment via institutional digital channel. 31.9% respondents know the institution have guidelines to prevent and respond to online harassment. 84.3%% respondents have never experienced any instance of sexual misconduct or harassment within the institution. 9% respondents prefer to maintain silence, 2.23% experienced multiple times, 1.12% experienced and 3.35% once experienced sexual misconduct or harassment. 93.7% respondents never reported any case of sexual harassment. 776 responses received regarding the cause of non-reporting of incidence of sexual harassment. Among them 35.8% respondents do not specify any reason, 25.3% do not know how to report, 15.2%% mention all the causes mentioned here like fear of retaliation/career impact, lack of faith in the process, social stigma/family consequences

Many suggestions for the improvement are received from students. Some important suggestions are cited below.

The ICC should organise regular awareness and the committee should be more visible and accessible on campus.

FINDINGS

- ❖ In the academic year 2025-2026 more number of male students have taken admission in the institution. In the institution 51.53% students are male and 49.47% are female. No student is found in the third gender category.
 - ❖ In 1st (50.64%) and 3rd (52.25%) semester female students outnumber the male students but in 5th semester a sharp decline in number of female students (41.62%) semester is witnessed.
 - ❖ In the institution male employees are more in number than female employees. There are 53.45% male employees and 46.55% female employees in the institution. No one is there in the 3rd gender category. In the teaching category female employees are more in number than male but in the non-teaching category male employees are more in number than female.
 - ❖ Good percentage of employees have awareness regarding gender equality, types of sexual harassment, Vishakha Guidelines/POSH Act, ICC and role of ICC, measures taken by college to foster equality.
